Executive Director Report

Mr. Kinard reported on the following items:

Orbach and MHA held several meetings with the tenants at 29 Ann Street to obtain feedback on the renovations and answer questions and concerns. Topics included, but were not limited to, better pest control in the building and units, the need to better understanding the heating system controls and the front door access system and more washers and dryers. It was stated that better instructions will be distributed to tenants and in-person demonstrations will also be given to tenants. Also, the number of washers and dryers will be increased. He stated that a 29 Ann Street renovation celebration is being planned for March 15 at 3:00 pm, hosted by Mayor Tim Dougherty. He discussed the various social services activities that occurred at 29 Ann Street and the Manahan Resident Center.

She stated that the residents may need transportation to the venue. She expressed interest in working with MHA to provide activities for our senior residents.

Mayor's Comments

Council Liaison's Comments -Robert Iannaccone

Councilman Iannaccone stated he was interested to learn more about the future role of the MHA from the prior direct property management to its new role. Also, Mr. Iannaccone noted that the Board needs to understand the role of MHA moving forward. Tenants should also know they can organize and advocate for their rights and how they may go about that. He further stated that the Council could potentially provide Colonial bus service for seniors to the arts center. He referenced that the Council passed an ordinance regarding tied garbage bags being closed in containers to minimize pest concerns. The Councilman further noted that there are many new affordable residential housing units that have been recently created in Morristown. He is concerned about who is overseeing and monitoring these projects that receive set-aside funds to ensure they are performing as expected. He stated maybe MHA could fit that role in the future.
